

## STATEMENT OF COMPLIANCE

TECNOLOGÍA NAVARRA DE NANOPRODUCTOS, S.L. – TECNAN, located at Perguita Industrial Zone, C/A, Nr. 1, P.C.:31210 – Los Arcos (Navarre – Spain), declares that the ceramic coating that protects against corrosion, provides hardness and that, additionally, provides hydrophobic and oleophobic properties, called **TECNADIS METALCOAT EASY TO CLEAN**, meets the relevant requirements stated by the following standards:

- Regulation (CE) 1935/2004 of the European Parliament and the Council, of the 27<sup>th</sup> of October of 2004, on materials and articles intended to come into contact with food, and by which Directives 80/590/EEC and 89/109/EEC are repealed.
- Directive 2005/31/CE of the Commission, of the 29<sup>th</sup> of April of 2005, amending Directive 84/500/EEC of the Council regarding the statement of compliance and performance criteria for the analysis of ceramic objects intended to come into contact with food.

The product has been manufactured according to the relevant requirements of the Regulation (CE) N°2023/2006 of the Commission, on good manufacturing practice for materials and articles intended to come into contact with food.

The product also complies with the test according to US. FDA (CPG 7117.06 & 7117.07), in terms of leachable lead and cadmium content.

The chemical composition of the product TECNADIS METALCOAT EASY TO CLEAN consists of a dispersion of ceramic nanoparticles.

Migration tests of the afore mentioned products have been carried out according to Directive 2005/31/CE, and have demonstrated that migration limits have not been exceeded in any case.

The Sensory testing of the product at issue, carried out according to the 3<sup>rd</sup> Article of Regulation (CE) N° 1935/2004 of the European Parliament and of the Council, of the 27<sup>th</sup> of October of 2004, under the method §64 LFGB L 00.90-6 1997-09, has evidenced that the organoleptic properties of foods are not altered at all:

The test of leachable lead and cadmium content for ceramics has been carried out according to the standard U.S. FDA CPG 7117.06 (2005) Sec 545.400, 7117.07 (2005) Sec 545.450 and A.O.A.C. Official Methods of Analysis, 18<sup>th</sup> edition by the 973.32 method of analysis of Atomic Absorption Spectrophotometry:
